Winterfest Policies & Procedures

1. The Festival hours are: Saturday, 10a-4pm. **Winterfest – Fire & Ice, is a multi-dimensional event with children’s activities, designated winter activities, food vendors, and live entertainment as well as arts & craft vendors.**
2. Set up begins at 8am on Saturday, January 17, 2009 and must be completed by 10a. Traffic and parking in this area is highly congested during set up. PLEASE plan to remove all items from your vehicle immediately and then begin organizing your booth space. Break down begins at 4pm on Saturday, October 18. Vehicles will not be allowed into the event area between 10am and 4pm on Saturday, January 17, 2009.
3. Please submit photos of your booth & a list of products along with your application. **This will insure we do not place same type vendors next to each other.**
4. The Chelan County Fire Department will make checks during the festival. If you have flammable Material you will be required to have a fire extinguisher.
5. Applications post marked after January 2 and will be charged an additional \$25 on a space available condition. **No refunds after January 2, 2009.**
6. Booth cost includes rental of space **and access to power for an additional \$FEE.** Power is provided to the outside corner of your booth. Vendors must provide a 12 gauge extension cord and proper “covering”. For insurance reasons, if safety concerns arise with your set up you may be asked to stop serving and close your booth until problem is fixed.
7. At no time are vendors allowed to appear intoxicated while operating their booth.
8. No pets, loud music or offensive odors are allowed.
